S.O. 4025.—In exercise of the powers conferred by the proviso to article 309 of the Constitution and in supersession of the notification of the Government of India in the Ministry of Finance (Defence) No. S.O. 1185, dated the 20th May, 1959, the President hereby makes the following rules regulating the method of recruitment to Class III and Class IV posts in the Defence Accounts Department, namely:—

1. Short title and commencement.—(1) These rules may be called the Defence Accounts (Class III and IV posts) recruitment Rules, 1970. (2) They shall come into force on the date of their publication in the Official Gazette.

2. Application.—These rules shall apply for recruitment to Class III and Class IV posts in the Defence Accounts Department as specified in column 2 of the Schedule annexed hereto.

3. Number, classification and Scale of Pay.—The number of posts, their classification and the scales of pay attached thereto shall be as specified in columns 3 to 5 of the said Schedule.

4. Method of Recruitment, age limits and other qualifications.—The method of recruitment to the said posts, age-limit, qualifications and other matters relating thereto shall be as specified in columns 6 to 15 of the Schedule aforesaid:

Provided that the upper age-limit specified for direct recruitment may be relaxed in the case of Scheduled Castes, Scheduled Tribes and other special categories of persons in accordance with the orders of the Central Government issued from time to time.

5. Disqualifications.—No person:—

(a) who has entered into or contracted a marriage with a person having a spouse living, or

(b) who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to service.

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and there are other grounds for so doing, exempt any person from the operation of this rule.

EXPLANATORY MEMORANDUM

The amendment is given retrospective effect as the Government orders notifying revised pay scales to Senior Stenographers attached to CGDA and other officers in the scale of Rs. 2250-1252-2500 and above were issued on 30-3-77 and 4-7-78 vide Government of India Ministry of Finance (Defence), New Delhi No. 64011(18)/76/AN/J(PC) dated 30-3-77 and Ministry of Home Affairs, Department of Personnel and Administrative Reforms O.M. No. 35014/5/77-Estt. (D) dated 4-7-78. The retrospection will not prejudicially affect the interest of any Government servant as the proposed amendment is intended only to embody the revised pay scales of Stenographers in the Recruitment Rules without any resultant change in the existing method of recruitment.

S.R.O. 370.—In exercise of the powers conferred by the proviso to article 309 of the Constitution the President hereby makes the following rules further to amend the Defence Accounts (Group 'C' and 'D' posts) Recruitment Rules, 1970 namely:—

1. (1) These rules may be called the Defence Accounts (Group 'C' and 'D' posts) Recruitment (Amendment) Rules, 1989.

(2) They shall come into force on the date of their publication in the Official Gazette.

2. In the Schedule to the Defence Accounts (Group 'C' and 'D' posts) Recruitment Rules, 1970,—A under the heading 'The Schedule Part-I Group 'C' Service',

(i) against the post at serial number 13 relating to the post of Hindi Translator Grade-II,—

(a) for the entry under column 7 the following entry shall be substituted, namely: '28 years'. (Relaxable for Government Servants upto 35 years in accordance with the instructions or orders issued by the Central Government).

Note.—The crucial date for determining the age limit shall in each case be the closing date for the receipt of applications from candidates in India (other than Andaman and Nicobar Islands and Lakshadweep).

In respect of posts, the appointments to which are made through the employment exchanges the crucial date for determining the age limit in each case, shall be the last date upto which the employment exchanges are asked to submit the names.

(b) for the entry under column 8, the following entry shall be substituted, namely:

'Master's degree of a recognised University in Hindi/English, with English/Hindi as a compulsory/elective subject or as medium of examination at degree level.

OR

Master's degree of a recognised university in any subject other than Hindi/English, with Hindi and English as compulsory/elective subjects or

either of the two as medium of examination and the other as a compulsory/elective subject at degree level.

OR

Master's degree of a recognised university in any subject other than Hindi/English, with Hindi/English medium and English/Hindi as a compulsory/elective subject or as medium of examination at degree level.

OR

Bachelor's degree of a recognised university with Hindi and English as compulsory/elective subjects or either of the two as medium of examination and the other as a compulsory/elective subject, plus a recognised Diploma/Certificate Course in Translation from Hindi to English and vice-versa or two years experience of translation work from Hindi to English and vice-versa in Central Government Offices/State Government Offices, including Government of India Undertakings;

(ii) serial number 6, 6A, 7 and 9 and the entries thereto shall be omitted;

(iii) against the post at serial number 60 relating to the post of Senior Stenographers attached to Dy. CGDA/Asstt. CGDA's, for the entry under column 2, the following entry shall be substituted, namely: 'Stenographers Grade-II attached to Dy. CGDA/Asstt. CGDA';

(iv) against the post at serial number 60 relating to the post of Senior Stenographers attached to the Dy. CGDA/Asstt. CGDA, for the entry under column 12, the following entry shall be substituted, namely:—

'By transfer of serving Stenographers Grade-II in Controller's Office selected by CGDA';

(v) against the post at serial No. 7-A relating to the post of Senior Stenographers attached to the Jt. Controller of Defence Accounts for the entry under column 2, the following entry shall be substituted, namely:

'Stenographers Grade-II attached to Jt. Controller of Defence Accounts';

(vi) against the post at serial number 7-A relating to the post of Stenographer attached to the Jt. CDA, for the entry under column 12, the following entry shall be substituted, namely,—

'By promotion from amongst stenographers, Grade-III in the scale of Rs. 1200—2040 with minimum of 5 years regular service in the grade on the basis of seniority subject to retention of the unit';

(vii) against the post at serial No. 8 relating to the post of Junior Stenographers in Controllers' Offices, for the entry under column 2, the following entry shall be substituted, namely:—
