SN	<u>Description/Nature of Power</u>	<u>Extent of Powers</u>
17	To enter into contracts and make payment for conducting courses with the help of outside Institutes/ Faculty either at Railway premises or premises of outside Institution.	Full powers subject to budgetary limit.
18	Deputation of faculty members and staff for training courses, workshops, conferences, seminars, symposia etc. in non-railway institute.	Pro rata registration fee and overall registration fee up to Rs.30,000/- per day (excluding taxes) and Rs.1.5 lakh (excluding taxes) respectively with ceiling of Rs.25 lakh per annum. -No finance concurrence is required.
22	Grant of individual cash award to non-gazetted staff and gazetted faculty/officers.	Same powers as General Managers in open line subject to an annual ceiling of Rs.3.00 lakh.
