

Sub: Institution Of 'Railway Minister's Medal For Best Investigation'.

A new medal called 'Railway Minister's Medal For Best Investigation' has been announced by the Hon'ble Minister for Railways on the occasion of 14th Raising Day Parade.

The rules governing the award of the above medal are being circulated for information and necessary action at your and.

Rules :-

- (1) The medal shall be known as 'Railway Minister's Medal for Best Investigation'.
- (2) It shall bearry a cash award of Rs. 20,000/- (Rupees Twenty thousand only) with it
- (3) It shall be awarded annually to a subordinate officer of the Force, of and above the rank of Assistant Sub-Inspector.
- (4) Each Zonal Railway may nominate, after being vetted by a Committee, one subordinate officer for consideration for the above award in the first week of September every year. If, in their opinion, there is no suitable case for nomination, they may send a Nil report. While sending the citation, details of investigation carried out be also given.
- (5) Collection of evidence, analysis of the same and presentation (complaint) of the case in the court of law, timely production of witnesses and case property and ensuring conviction should be the other factors to be considered while nominating a case.
- (6) The nominations shall be scrutinised by a Committee of Officers nominated by DG/RPF and the awardee will be selected.
- (7) The recommendation shall be put up to Minister for Railways through DG/RFF and Member (Staff) for approval.
