With reference to the communication cited under reference, following is advised:

- 2. PCA (Fys) Kolkata may please refer to this Office letter dated 28.09.2016 wherein it was F/A clarified that the pay fixation on account of absorption of "Midwifes (GP 2000)" in the post of Sr. Nurse Gr. II (GP 4600) was to be regulated by treating them as direct recruitment.
- Hence, pay fixation of those Midwifes who have been absorbed to the post of Senior Nurse Gr. II may be carried out as per provisions contained in CCS (RP) Rules 2008 or CCS RPR 2016 as applicable to direct recruitment.

It may be seen in column 11 of the SRO 88 dated 03-08-2005 as amended vide pa 3 (e) (ii) of SRO 36 dated 24-03-2008 that appointment to the post of Senior Nurse Gra II is to be made by absorption of Midwife with qualification in column 8 failing which direct recruitment. However column No 12 of ibid SRO, meant for providing the details grade from which promotion/deputation/absorption is, to be made and minimular qualifying service in that grade does not provide any such details and mentions that the direct recruitment is the only method for appointment to the post of Senior Nurse Gra II. As such, it is viewed that column 12 of SRO 88 dated 03-08-2005 need to be amended first to accommodate the amended column 11. Further Note 4 below SRO explaining term "absorption" describes the cases which are to be treated as absorption; it nowh prescribes for the manner of pay fixation in such cases. Accordingly, it is viewed that pay fixation on account of appointment to the post of Senior Nurse Grade II is to regulated by treating the appointees as directly recruited to that post and according benefit of pay fixation as per FR 22 (1) (a) (1) may not be admissible in such cases.
