As you are aware, pension revision of those pensioners who are drawing pension from Post Offices/ Treasuries is being done outside ARPAN- (either manually or on an in-house software) and progress reported to Board's Office in MCDO. This data (concerning pension revision of such pensioners) is required for registration under UMID Portal. Hence, ARPAN team /WR has suggested an excel file format for porting of this data to ARPAN portal so that the same can be shared with UMID portal to facilitate registration process.

It is, therefore, requested that suitable arrangements may kindly be made for porting of this data to ARPAN Portal immediately.

Sub: Submission of 7th CPC revised pension data –Postal/Treasury Pensioners

A reference has been received from Railway Board regarding non-porting of pension data of Postal/Treasury pensioner to ARPAN portal and subsequent transmission of data to UMID portal for enabling such Postal/Treasury pensioners for registration of UMID Card with exiting PPO number and New\_PPO\_Number (with /without 14 digit unique number).

Since these cases were to be revised outside ARPAN, a number of such cases might have been revised manually or on local platform as progress report thereof is regularly being included in 'MCDO to Rly Bd' by Zonal railways/PUs. However due to non submission data of such pensioners to WR-ARPAN, it has not been possible the share their details with UMID portal, resulting in difficulty for UMID registration of such pensioners/family pensioners.

Hence it is requested to arrange to provide the 7<sup>th</sup> CPC revised data of all such Postal/Treasury pensioners urgently in the attached Excel file format (*Annexure*), for porting into ARPAN as well as UMID.
