

As per Board's letter under reference, instructions were issued for introduction of 100% objective type test for all departmental selections in non-gazetted category (excluding the Accounts & RPF).

An issue has been raised from a training centre of this railway whether such pattern of departmental promotional examination based on 100% objective paper may also be introduced for the written examinations being conducted in training centres at the end of promotional courses for various categories like Technical Supervisors (JEs/SSEs) etc etc.

It is felt that if this pattern is applied for promotional courses' examinations also, it would expedite and simplify the process.

Board is requested to provide guidelines in the matter. This is being sent with the approval of PCPO/SECR.
