OFFICE MEMORANDUM

Sub: - De-empanelment of Seven Star Hospital, 324/01, Jagnade Square, KDK College Road, Nagpur from CGHS, Nagpur Empanelled List.

As per this Office Letter no. CGHS/NP/CMO(Hospital)/PBG/2021/2090 dated 12.10.2021, it was informed to you, that the validity period of the Performance Bank Guarantee No. 102GT102182810002 submitted by you on 08.10.2018 for empanelment of your hospital under CGHS expired on **07.10.2021** and you were advised to submit a fresh Performance Bank Guarantee (PBG) or renew the earlier Performance Bank Guarantee of Rs. 10 Lakh for a period of 36 Months (03 Years) **on or before 25.10.2021**, as this is mandatory for the hospital to remain empanelled under CGHS.

As per this office letter no. CGHS/NP/CMO (Hospital)/PBG/2021/3251 dated 04.01.2022, you were once again instructed to submit a fresh Performance Bank Guarantee (PBG) or renew the earlier Performance Bank Guarantee of Rs. 10 Lakh for a period of 36 Months (03 Years) **on or before 10.01.2022** and it was informed to you that, if you fail to submit the same, your hospital will be de-empanelled from CGHS without any further notice and no further communication in this regard will be entertained.

Hence, **Seven Star Hospital, 324/01, Jagnade Square, KDK College Road, Nagpur-440024 is de-empanelled due to Non submission of Performance Bank Guarantee (PBG) from CGHS Nagpur panel with immediate effect.** The CGHS beneficiaries already being admitted in the hospital prior to the issue of this order shall however be continued to be provided treatment at CGHS rate till completion of their treatment and their bills would be submitted to NHAI / concerned department with justification, for consideration on merits.
