

The above will not entail any change of pay levels, recruitment rules, seniority and duties & responsibilities.

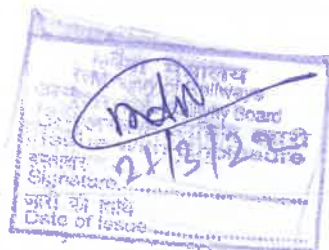
