Sub: Travelling Allowance Rules -Implementation of the Seventh Central Pay Commission.

Consequent upon the decisions taken by the Government on the recommendations of the Seventh Central Pay Commission relating to Travelling Allowance entitlements, sanction of the President is conveyed to the revision in the Rallway Travelling Allowance Rules as set out in the Annexure to this letter.

- 2. The 'Pay Level' for determining the TA/DA entitlement is as indicated in the Railway Services (Revised Pay) Rules, 2016.
- 3. The term 'Pay' in the level for the purpose of these orders refer to Basic Pay drawn in appropriate Pay Level in the Pay Matrix as defined in Rule 3(8) of Railway Services (Revised Pay) Rules, 2016 and does not include Non-Practising allowance (NPA), or any other type of pay like special pay etc.
- 4. However, if the Travelling Allowance entitlements in terms of the revised entitlements now prescribed result in a lowering of the existing entitlements in the case of any individual, groups or classes of employees, the entitlements, particularly in respect of mode of travel, class of accommodation, etc., shall not be lowered. They will instead continue to be governed by the earlier orders on the subject till such time as they become eligible, in the normal course, for the higher entitlements.
- 5. The claims submitted in respect of journey made on or after 1<sup>st</sup> July, 2017, may be regulated in accordance with these orders. In respect of journeys performed prior to 1<sup>st</sup> July, 2017, the claims may be regulated in accordance with the previous orders dated 01.12.2008.
- 6. It may be noted that no additional funds will be provided on account of revision in TA/DA entitlements. It may therefore be ensured that permission to official travel is given judiciously and restricted only to absolutely essential official requirements.
- These orders shall take effect from 1<sup>st</sup> July, 2017.

## Annexure to Board's letter No. F(E)I/2017/AL-28/41 dated 24.08.2017.

In partial modification of Railway Travelling Allowance Rules contained in Chapter 16–IREC-Vol.II (2005 Edition) and Board's letters No. F(E)I/2008/AL-28/14 and F(E)I/2008/AL-28/15, dated 01.12.2008, the following provisions will be applicable with effect from 01.07.2017.

## 2. Entitlements for Journeys on Tour or Training

#### A. Journeys by Air within the Country.

- (I) Officers in Level-16 and above, while on tour, may be entitled for air travel in 'J'/ Business Class.
- (ii) All other Officers, otherwise authorized to travel by Air may be entitled to travel by economy class.

All mileage points earned by Railway employees on tickets purchased for official travel shall be utilized by the Railway for other official travel by their officers. Any usage of these mileage points for purposes of private travel by an officer will attract departmental action. This is to ensure that the benefits out of official travel, which is funded by the Railway, should accrue to the Railway. It is the responsibility of the officer concerned to ensure that free mileage points are used only for official travel and not for personal trips. Any other incentives and similar packages such as free companion etc. should be so negotiated that the benefits come to the Railway.

#### E. Journeys by Rail:

Free passes, as admissible under Rules, may be issued to a Railway servant.

#### 3. TA entitlements on Transfer

TA on Transfer includes 4 components: (A) Travel entitlement for self and family (B) Composite Transfer and packing grant (CTG) (C) Reimbursement of charges on transportation of personal effects (D) Reimbursement of charges on transportation of conveyance.

#### A. Travel Entitlements:

(i) Journeys by Air: Officers in Level-15 and above, while on transfer, may be entitled for air travel in 'J'/ Business Class, at their discretion to join the new HQs. Officers in level 14 may also be permitted to travel by air with the approval of Competent Authority, subject to exigency and where joining at transfer station has to be effected with immediate effect. This is also subject to fulfillment of conditions as per Board's letter no. F(E)I/2003/AL-28/7 dated 16.9.2003. The air fare is, however, admissible for self only. No family member of any Railway servant is entitled to travel by air on transfer.

- (ii) <u>Journeys by Rail:</u> Free passes, as admissible under Rules, may be issued to a Railway servant and his family members.
- (ill) Journeys by Road: A Railway servant is not entitled to travel by road, between stations connected by rail. However, between stations not connected by rail a railway servant and his family members may travel by road. The entitlement in this regard is same as para 2(D) above.

## B. Composite Transfer and Packing Grant (CTG):

- (I) The Composite Transfer Grant shall be paid at the rate of 80% of the last month's basic pay in case of transfer involving a change of station located at a distance of or more than 20 kms. from each other. Further, NPA shall not be included as part of basic pay while determining entitlements for CTG.
- (ii) In cases of transfer to stations which are at a distance of less than 20 kms. from the old station and of transfer within the same city, one third of the composite transfer grant will be admissible, provided a change of residence is actually involved.
- (iii) In cases where the transfer of husband and wife takes place within six months, but after 60 days of the transfer of the spouse, fifty percent of the transfer grant on transfer shall be allowed to the spouse transferred later. No transfer grant shall be admissible to the spouse transferred later, in case both the transfers are ordered within 60 days. The existing provisions shall continue to be applicable in case of transfers after a period of six months or more. Other rules precluding transfer grant in case of transfer at own request or transfer other than in public interest, shall continue to apply unchanged in their case.

## C. Transportation of personal effects:

These rates will further rise by 25% whenever DA increases by 50%. The claim for reimbursement shall be admissible subject to the production of actual receipts / vouchers by the railway servants.

#### D. Transportation of conveyance.

Reimbursement of charges on transportation of conveyance as admissible under Rules, may be provided.

#### 4. TA entitlement on retirement

TA on retirement includes 04 components: (A) Travel entitlement for self and family (B) Composite Transfer and packing grant (CTG) (C) Reimbursement of changes on transportation of personal of effects (D) Reimbursement of charges on transportation of conveyance.

A. Travel Entitlements: same as para 3(A) above

#### B. Composite Transfer Grant:

(I) The composite Transfer Grant shall be paid at the rate of 80 % of Basic Pay last drawn in case of those Railways employees, who on retirement, settled down at places other that last station of their duty located at a distance of

or more than 20 Km. However, in case of settlement to and from the island territories of Andaman, Nicobar & Lakshadweep. CTG shall be paid at the rate of 100% of basic pay last drawn. The transfer incidentals and road mileage for journeys between the residence and the railway stations/ bus stand etc. at the old and new station, are already subsumed in the CTG and will not be separately admissible.

- (ii) For Railway servants, who on retirement settle at the last station of duty itself or within the distance of less than 20 Kms, may be paid one third of the CTG subject to the condition that a change of residence is actually involved.
- C. Transportation of Personal Effects: Same as para 3(C) above.
- D. Transportation of conveyance: Same as para 3(D) above.

In continuation to Board's letter of even number dated 24.08.2017 regarding implementation of recommendations of the Seventh Central Pay Commission relating to Travelling Allowance entitlements, the admissibility of CTG and Transportation of personal effects on Transfer and Retirement will be regulated as under:

- (I) In case, the railway servant has been transferred prior to 01.07.2017 and has assumed charge prior to 01.07.2017, he will be eligible for CTG at pre-revised scale of pay. If the personal effects have been shifted after 01.07.2017, revised rates for transportation of personal effects will be admissible.
- (ii) In case, the railway servant has been transferred prior to 01.07.2017 and has assumed charge on/after 01.07.2017, he will be eligible for CTG at revised scale of pay. As the personal effects would be shifted after 01.07.2017, revised rates for transportation of personal effects will be admissible.
- (III) In case of retirement, if a railway servant has retired prior to 01.07.2017, he will be eligible for CTG at pre-revised scale of pay. If the personal effects have been shifted after 01.07.2017, revised rates for transportation of personal effects will be admissible.
- 2. Hindi version will follow.

#### OFFICE MEMORANDUM

Subject:- Grant of Deputation (Duty) Allowance - Recommendations of the Seventh Central Pay Commission-Regarding.

This Department's QM No. 6/8/2009-Estt (Pay-II) dated 17.6.2010 interalia provides for rates of Deputation (Duty) Allowance admissible to Central Government employees.

- 2. As provided in para 7 of Ministry of Finance, Department of Expenditure's Resolution No.1-2/2016-IC dated 25th July, 2016, the matter regarding allowances (except Dearness Allowance) based on the reconfinendations of the 7th Central Pay Commission (CPC) was referred to a Committee under the Chairmanship of Finance Secretary and until a final decision-thereon, all Allowances have been paid at the existing rates in the existing pay structure.
- 3. The decision of the Government on various allowances based on the recommendations of the 7th CPC and in the light of the recommendations of the Committee tinder the Chairmanship of the Finance Secretary has since been issued as per the Resolution No.11-1/2016 IC dated 6th July 2017 of Department of Expenditure.
- 4. As mentioned at SI.No.46 of the Appendix-II of the said Resolution dated 6th July 2017, the recommendation of the 7th CPC for enhancement of ceiling of Deputation (Duty) Allowance for civilians by 2.25 times has been accepted and this decision is effective from 1st July, 2017. Accordingly, the President is pleased to decide that the rates of Deputation (Duty) Allowance and certain other conditions relating to grant of Deputation (Duty) Allowance shall be as under:

The Deputation (Duty) Allowance admissible shall be at the following rates:

- (a) In case of deputation within the same station the Deputation (Duty) Allowance will be payable at the rate of 5% of basic pay subject to a maximum of Rs.4500 p.m.
- (b) In case of deputation involving change of station, the Deputation (Duty) Allowance will be payable at the rate of 10% of the basic pay subject to a maximum of Rs. 9000 p.m.
- (c) The ceilings will further rise by 25 percent each time Dearness Allowance increases by 50 percent.
- (d) Basic Pay, from time to time, plus Deputation (Duty) Allowance shall not exceed the basic pay in the apex level i.e. Rs. 2,25,000/-. In the case of Government servants receiving Non Practising Allowance, their basic pay plus Non-Practising Allowance plus Deputation (Duty) Allowance shall not exceed the average of basic pay of the revised scale applicable to the Apex Level and the Level of the Cabinet Secretary i.e. Rs. 2,37,500/-.
- Note: 1 Basic pay in the revised pay structure (the pay structure based on 7th Central Pay Commission recommendations) means the pay drawn by the deputationist, from time to time, in the prescribed Level, in Pay Matrix, of the post beld by him substantively in the parent cadre, but does not include any other type of pay like personal pay, etc.
- Note: 2 In cases where the basic pay in parent cadre has been upgraded on account of non-functional upgradation [NFU], Modified Assured Career Progression Scheme (MACP), Non-Functional Selection Grade (NFSG), etc., the upgraded basic pay under such upgradations shall not be taken into account for the purpose of Deputation (Duty) Allowance.
- Note 3 In the case of a Proforma Promotion under Next Below Rule (NBR): If such a Proforma Promotion is in a Level of the Pay Matrix which is higher than that of the ex-cadre post, the basic pay under such Proforma Promotion shall not be taken into account for the purpose of Deputation (Duty) Allowance: However, if such a Proforma Promotion under NBR is in a Level of the pay matrix which is equal to or below that of the ex-cadre post, Deputation (Duty) Allowance shall be admissible on the basic pay of the parent cadre post allowed under the proforma promotion, if opted by the deputationist.

- Note 4 In case of Reverse Foreign Service, if the appointment is made to post whose pay structure and/ or Dearness Allowance (DA) pattern is dissimilar to that in the parent organisation, the option for electing to draw the basic pay in the parent cadre [alongwith the Deputation (Duty) Allowance thereon and the personal pay, if any] will not be available to such employee.
- Note: 5 The term 'same station' for the purpose will be determined with reference to the station where the person was on duty before proceeding on deputation.
- Note: 6 Where there is no change in the headquarters with reference to the last post held, the transfer should be treated as within the same station and when there is change in headquarters it would be treated as not in the same station. So far as places falling within the same urban agglomeration of the old headquarters are concerned, they would be treated as transfer within the same station.
- 5. Para 6.1 of this Department's OM No.6/8/2009-Estt(Pay-II) dated 17.6.2010 stands amended to the above effect.
- 6. In so far as persons serving in the Indian Audit & Accounts Department are concerned, these orders issue after consultation with the Comptroller & Auditor General of India.
- 7. These orders shall take effect from 1st July, 2017.

Subject: Grant of Deputation (Duty) Allowance in cases where the basic pay in parent cadre has been upgraded on account of NFU, MACP, NFSG, etc. inthe 7th CPC context - clarification regarding.

The undersigned is directed to refer to this Department's OM of even number dated 24th November, 2017 regarding grant of Deputation (Duty) Allowance in the 7th CPC context, and to say that this Department has been receiving references from various Ministries/Departments/Organizations for clarifications regarding admissibility of Deputation (Duty) Allowance in terms of Note 2 and Note 3 below para 4(d) of this Department's OM dated 24th November, 2017 in cases where the basic pay in parent cadre has been upgraded on account of NFU, MACP, NFSG, etc. in the 7th CPC context.

2. Note 2 and Note 3 of the para 4(d) of this Department's OM dated  $24^{th}$  November, 2017 are as follows:-

'Note 2 In cases where the basic pay in parent cadre has been upgraded on account of Non-functional upgradation (NFU), Modified Assured Career Progression Scheme (MACP), Non Functional Selection Grade (NFSG), etc., the upgraded basic pay under such upgradations shall not be taken into account for the purpose of Deputation (Duty) Allowance.

Note 3 In the case of a Proforma Promotion under Next Below Rule(NBR): If such a Proforma Promotion is in a Level of the Pay Matrix which is higher than that of the ex-cadre post, the basic pay under such Proforma Promotion shall not be taken into account for the purpose of Deputation (Duty) Allowance. However, if such a Proforma Promotion under NBR is in a Level of the pay matrix which is equal to or below that of the ex-cadre post, Deputation (Duty) Allowance shall be admissible on the basic pay of the parent cadre post allowed under the proforma promotion, if opted by the deputationist.

- 3. In view of the references received from different Ministries/Departments/Organisations, the following is clarified with regard to the admissibility of Deputation (Duty) Allowance in terms of Note 2 and Note 3 below para 4(d) of this Department's OM dated 24th November, 2017 in cases where the basic pay in parent cadre has been upgraded on account of NFU, MACP, NFSG, etc. in the 7th CPC context:-
- 3.1 In cases where the basic pay in parent cadre has been upgraded (upto Level 13 A) on account of Non-Functional Upgradation (NFU), Modified Assured Career Progression Scheme (MACP), Non Functional Selection Grade (NFSG), etc., and the officer has opted for such upgraded pay of the parent cadre, in that event, the upgraded basic pay under such upgradations shall not be taken into account for the purpose of Deputation (Duty) Allowance. In such cases, the Deputation (Duty) Allowance will be calculated taking the basic pay of the parent cadre which the officer was getting before such upgradation and the amount of the same would be further regulated every year on the basis of the pay arrived at by giving annual increments on the presumptive pay.
- 3.2 However, if the upgradation is to <u>Level 14</u> or above, he shall be given the option to draw the upgraded basic pay under such upgradations without Deputation (Duty) Allowance or the pay which he was drawing before such upgradation with Deputation (Duty) Allowance, whichever is more beneficial as per the option of the officer.
- 3.3 In the case of Proforma Promotion under Next Below Rule (NBR), if such a Proforma Promotion (upto Level 13 A) is in a Level of the Pay Matrix which is higher than that of the ex-cadre post, and the officer has opted for the upgraded pay of the Proforma Promotion, the basic pay under such Proforma Promotion shall not be taken into account for the purpose of Deputation (Duty) Allowance. Deputation (Duty) Allowance will be calculated taking into account the basic pay which the officer was getting before such Proforma Promotion. The amount of Deputation (Duty) Allowance would be calculated on the basis of the pre-upgraded presumptive pay that the officer was drawing prior to Proforma Promotion and the amount of the same would be further regulated every year on the basis of the pay arrived at by giving annual increments on the presumptive pay.
- 3.4 However, if such a Proforma Promotion under NBR is in a Level of the pay matrix which is equal to or below that of the ex-cadre post, Deputation (Duty) Allowance shall be admissible on the basic pay of the parent cadre post allowed under the Proforma Promotion, if opted by the deputationist.
- 3.5 However, if the upgradation is to Level 14 or above of the Pay Matrix, he shall be given the option to draw the upgraded basic pay under such Page 2 of 3

Proforma Promotion without Deputation (Duty) Allowance or the pay which he was drawing before grant of Proforma Promotion with Deputation (Duty) Allowance, whichever is more beneficial as per the option of the officer. The amount of Deputation (Duty) Allowance would be calculated on the basis of pre-upgraded presumptive pay that the officer was drawing prior to the grant of Proforma Promotion and the amount of the same would be further regulated every year on the basis of the pay arrived at by giving annual increments or the presumptive pay.'

- These orders shall take effect from 1st July, 2017.
- 5. Insofar as the persons serving in the Indian Audit and Accounts Department are concerned, these orders issue in consultation with the office of the Comptroller and Auditor General of India.

The undersigned is directed to refer to this Ministry's OM No A45012/04/2017-CHS V(PT) dated 09.04.2019 on the above mentioned subject and to say that rate of conveyance allowance admissible to Central Health Service (CHS) doctors working in Hospitals/Dispensaries /Stores in CGHS Units under Central Government have been under consideration of the Government of India.

2. With the approval of Competent Authority it has now been decided that the amount of Conveyance Allowance per month admissible to Central Health Service (CHS) doctors working in Hospitals/Dispensaries/Stores in CGHS Units for visiting Hospitals or paying domiciliary visits outside duty hours and performing other official duties, will be as indicated below:

SI, No	Mode of Conveyance	Maximum Rates p.m.	Minimum Rates
(i)	For those who maintain their own Motor Car	7150/-	350/~
(ii)	For those who maintain Scooter/Motor Cycle	2350/-	175/-
(iii)	For those who do not maintain either Car or Motor Cycle/Scooter	1950/-	130/-

- 3. The amount of the Conveyance Allowance will go up by 25 percent each time DA rises by 50 percent as would be done in respect of other DA linked allowances.
- 4. For entitlement to the maximum amount of Conveyance Allowance mentioned in Para 2 above, every Specialist/General Duty Medical Officer is required to pay on an average (to be computed for a three month period) a minimum of 20 visits in a month to the hospital or 20 domiciliary visits outside his normal duty hours. Where however, the number of domiciliary visits or visits to hospital fall short of this

minimum limit of 20 but not below 6, there should be a proportionate reduction in the conveyance Allowance, subject to minimum grant of conveyance allowance of Rs. 350/-, Rs. 175/- and Rs. 130/- p.m. In case of number of domiciliary visits or visits to the hospital falling below six in number, no conveyance will be admissible. The limit fixed for the minimum number of 20 visits will not however detract a Specialist/Medical Officer from their responsibility towards the patients to render visit to the hospital or paying domiciliary visits if the situation so warrants.

- 5. Every Specialists/Medical Officer claiming conveyance allowance will have to furnish a certificate along with monthly pay bill to the effect that he is drawing conveyance allowance in fulfillment of condition No. 4 above.
- 6. No conveyance allowance will be admissible during joining time, leave and any period of temporary transfer.
- Medical Officers/Specialists who draw conveyance allowance at the minimum rate specified in Para 2 above and those who do not maintain a motor Car or Motor Cycle/Scooter and draw conveyance allowance @ Rs. 1950/- or Rs. 130/- p.m. as the case may be, will be required to furnish a certificate along the monthly pay bill, to the effect that the expenditure incurred by them by way of transport/conveyance hire in connection with domiciliary visits/official duty was not less than the amount claimed by them as conveyance allowance.
- 8. Specialists/Medical Officer in receipt of conveyance allowance will not be entitled to draw any Daily Allowance or Mileage Allowance for journeys on official duty, whether, within or beyond a radius of eight kilometers within the city municipal limits.
- 9. In case the conveyance is not maintained or is not available for use, owing to its being out of order or is not used for official journeys/hospital visit for any other reason, for a period of more than 15 days at a time, conveyance allowance will be admissible during such period at the rate prescribed in 2 (iii) above.
- 10. In the case of Medical Officers/Specialists posted to Hospital Departments in the Dr. Ram Manohar Lohia Hospital and Safdarjung hospital under the CGHS, conveyance allowance in terms of this order will be admissible to those Medical Officers/Specialist who have been allotted a number of CGHS dispensaries and are also available for consultation at the residence of the beneficiaries attached to those dispensaries. Other Medical Officers/Specialists posted to the aforesaid hospitals under the CGHS who are normally not expected to visit dispensaries but occasionally pay domiciliary visits in their zone will be granted conveyance allowance on the basis of log book maintained by them in terms o the Ministry of Finance General orders contained in their OM No. F. 11(5)-E.IV(B)/60dated the 24<sup>th</sup> May, 1961 as amended from time to time.

Sub: Concessions to person re-employed in Central Government service – payment of Travelling Allowance.

In pursuance to Ministry of Finance / Department of Expenditure O.M. No 19030/42020-E.IV dated 24.01.2022 on the subject matter of concessions to person reemployed in Central Government service – payment of Travelling Allowance, it has been decided to regulate admissibility of Travelling Allowance (i.e. TA for self and family members, Composite Transfer Grant, transportation of personal effects and transportation of conveyance) in r/o persons re-employed in Railways in the following manner:

- (i) Where the pensioner is re-employed and TA on retirement has already been claimed by re-employed pensioner from the office/organization from where he has retired/superannuated:
  - a. TA shall be allowed to him for such appointment if such appointment is made at station other than place of settlement or such appointment necessitates change of residence at place of settlement.

b. TA shall also be allowed to him after completion of his term of reemployment.

- c. In both cases, the TA would be reimbursed by the office/organization where the pensioner is re-employed.
- (ii) In case the re-employed pensioner has not claimed TA on retirement within one year of his retirement and he is re-employed under the Railway before the expiry of one year from the date of retirement:
  - a. TA shall be allowed to him for such appointment in case such appointment is made at station other than last station of duty or such appointment necessitates change of residence at last station of duty.

b. TA shall also be allowed to him after completion of his term of reemployment.

c. The expenditure for TA on joining such appointment shall be borne by the organization from where the pensioner is retired/superannuated with reference to the post held at the time of retirement. On completion of term of re-

- (iii) In case of appointment of a re-employed person from other than Railway, TA shall be allowed to him as per the provision at Para 1 (i) above.
- 2. Admissibility of TA in above cases would be subject to the following:
  - i. The entitlement for TA would be w.r.t. the post last hold and the last pay drawn under the Railway at the time of retirement. In case of appointment of a re-employed person from other than Railway, the entitlement of TA would be in accordance with the equivalence given to the post in Railway.

ii. Other provisions of Railway TA rules as provided in Chapter-16 of Indian Railway Establishment Code admissible to Railway officials on transfer in public interest as modified from time to time, would be applicable.

3. This order shall be effective from date of issuance of this OM. Past cases already settled would not be re-opened.

E(MPP)/2005/13/2 dated 22.08.2005 (RBE No. 139/2005) followed by E(MPP)/2008/3/18 dated 20.10.2008 (RBE No. 156/2008) wherein Ministry of Railways had communicated that the training allowance is to be paid @ 30% and @ 15% of the basic pay to the faculty members, for imparting training to Group 'A' Officers and to Group 'C' & 'D' staff respectively on Centralised Training Institutes and various other training Centres on Indian Railways, respectively.

2. Pursuant to the recommendation of 7<sup>th</sup> CPC as per Ministry of Finance, Department of Expenditure- Resolution No. 1/1/2013 -E.III(A) dated 06.07.2017, the rates of Training Allowance is revised as follows:

3. It will be admissible only to the employees who join the training establishments for a specified period of time and are then likely to go back. It will

- 4. Training Allowance will be admissible to the faculty members without any ceiling of 5 years and standard cooling off period between tenures will apply.
- 5. Further, above mentioned Board's instruction had stated that 'Sumptuary Allowance' shall be paid @ Rs 3500/- per month for the Director/ Head of the Centralised Training Instititutes for Group 'A' Officers and @ Rs 2500/- per month to Course Directors and @ Rs 2000/- per month to Coursellors. Pursuant to the recommendation of 7<sup>th</sup> CPC recommendation and as per Ministry of Finance, Department of Expenditure- Resolution No. 1/1/2013 –E.III(A) dated 06.07.2017, 'Sumptuary Allowance' for Training Establishment is abolished.
- 6. The revised rates of allowances and abolition of Sumptuary Allowance shall be applicable with effect from 1<sup>st</sup> July, 2017.
- 7. All other guidelines/instructions on the subject shall remain unchanged.
- 8. This issues with the concurrence of Finance Directorate of the Ministry of Railways.



Recommendations of the Seventh Central Pay Commission – Implementation of decision relating to the grant of Children Education Allowance.

Consequent upon the decision taken by the Government on the recommendations made by the Seventh Central Pay Commission on the subject of Children Education Allowance Scheme, the following instructions are being issued in supersession of this Department's OM dated 28-4-2014:

- (a) The amount fixed for reimbursement of Children Education allowance will be Rs.2250/-pm.
- (b) The amount fixed for reimbursement of Hostel Subsidy will be Rs. 6750/-pm.
- (c) In case both the spouses are Government servants, only one of them can avail reimbursement under Children Education Allowance.
- (d) The above limits would be automatically raised by 25% every time the Dearness Allowance on the revised pay structure goes up by 50%. The allowance will be double for differently abled children.
- 2. Further, reimbursement will be done just once a year, after completion of the financial year. For reimbursement of CEA, a certificate from the head of institution, where the ward of government employee studies, will be sufficient for this purpose. The certificate should confirm that the child studied in the school during the previous academic year. For Hostel Subsidy, a similar certificate from the head of institution will suffice, with the additional requirement that the certificate should mention the amount of expenditure incurred by the government servant towards lodging and boarding in the residential complex. The amount of expenditure mentioned, or the ceiling as mentioned above, whichever is lower, shall be paid to the employee.

- 3. These orders shall be effective from 1st July, 2017.
- 4. Insofar as persons serving in the Indian Audit and Accounts Department are concerned, these orders issue in consultation with the Comptroller and auditor General of India.

- (iv) उपर्युक्त सीमा, संशोधित वैतन संरचना में मंहगाई भत्ते में 50% तक की वृद्धि होने पर स्वतः 25% बढ़ जाएगी।

DETAILS OF PACKAGE OF CONCESSIONS/INCENTIVES TO CENTRAL GOVERNMENT EMPLOYEES WORKING IN KASHMIR VALLEY IN ATTACHED/SUBORDINATE OFFICES OR PSUS FALLING UNDER THE CONTROL OF CENTRAL GOVERNMENT.

[Kashmir Valley comprises of ten districts namely Anantnag, Baramulla, Budgam, Kupwara, Pulwama, Srinagar, Kulgam, Shopian, Ganderbal and Bandipora]

a) Extension of Special concessions/incentives for a further period from 01.01.2020 to 31.07.2021 to Central Government employees working in the 10 districts of Kashmir Valley.

# I. ADDITIONAL HOUSE RENT ALLOWANCE AND OTHER CONCESSIONS:

# (A) EMPLOYEES POSTED IN KASHMIR VALLEY:

- (i) The employees shall have an option to move their families to a selected place of their choice in India at Government expenses and the transport allowance for the families are proposed to be allowed as admissible in permanent transfer inclusive of the Composite Transfer Grant at the rate of 80 per cent of the last month's basic pay;
- (ii) Departmental arrangements for stay, security and transportation to the place of work for employees;

(iii) Additional house rent allowance at the rate of Class 'Y' city (16 per centof basic pay) for employees who leave their family at their last place of posting, except officials who have retained Government accommodation to accommodate their families and these employees shall be eligible for drawing the normal house rent allowance as well as at their place of posting if the Departmental arrangement is not made for his stay;

# (B) EMPLOYEES POSTED TO KASHMIR VALLEY WHO DO NOT WISH TO MOVE THEIR FAMILIES TO A SELECTED PLACE OF RESIDENCE.

The per diem allowance of Rs. 113/- per day is paid for each day of attendance to compensate for any additional expense in transportation from to and from office etc. in terms of the Department of Expenditure OM No. 19030/11/2017-E.IV, dated 13.07.2017.

# (C) THE PERIOD OF TEMPORARY DUTY EXTENDED TO SIX MONTHS.

For period of temporary duty, an incentive known as the Kashmir Valley Special Incentive will be paid at the following rates along with food charges (as per 7th Pay Commission norms), apart from departmental arrangements for stay, security and transportation:

# II. MESSING FACILITIES:

Messing allowance is paid @ Rs.97.85/- per day.

#### III. PAYMENT OF MONTHLY PENSION:

The pensioners of Kashmir Valley who are unable to draw their monthly pensions through either Public Sector Banks or Pay and Accounts Office treasuries from which they were receiving their pensions, are given pensions outside the Valley, where they have settled, in relaxation of relevant provisions.

#### NOTE:-

- The package of concessions / incentives shall be admissible in Kashmir Valley comprising of ten Districts namely, Anantnag, Baramulla, Budgam, Kupwara, Pulwama, Srinagar, Kulgam, Shopian, Ganderbal and Bandipora.
- ii. The Package of concessions / incentives shall be admissible to Temporary Status Casual Laborers working in Kashmir Valley in terms of Para 5(i) of the Casual Laborers (Grant of Temporary Status and Regularization) Scheme of Government of India, 1993.
- iii. The benefit of additional house rent allowance admissible under the Kashmir Valley package shall be admissible to all Central Government employees posted in Kashmir Valley irrespective of whether they are natives of Kashmir Valley, if they choose to move their families anywhere in India subject to the conditions governing the grant of these allowances.
- iv. The facilities of Messing Allowance and Per Diem Allowances shall also be allowed to natives of Kashmir Valley in terms of the Kashmir Valley package.
