

### SUBMISSION OF ANNUAL LIFE CERTIFICATES BY PENSIONERS

1. It is mentioned that submission of Annual Life Certificates by pensioners has emerged as a major challenge after implementation of SPARSH. Approx 4.5 lakh pensioners are yet to submit their life certificates. In case the same is not submitted by 20 Feb 23, remittance of monthly pension might get affected.
2. To facilitate pensioners, PCDA(P) has made arrangements to obtain life certificates through banks for importing into SPARSH. In this connection, a copy of PCDA (P) letter No EDP/58/ CPP/2022/Vol-II dt 13 Oct 22 is enclosed herewith.
3. Pensioners may please be advised to visit banks and submit life certificates as was being done before.
4. For further dissemination to all concerned and wide publicity through ZSBs, CSD Canteens, ECHS Polyclinics, ESM Cells and all other possible means please.

**Sub:** Facility for Identification/Life Certificate for Migrated Pensioners by the Banks

**Ref:** Meeting held on above subject through VC on 12.10.2022

As project SPARSH has been implemented, large number pensioners have been migrated on SPARSH. Communication through various modes i.e. SMS, mails, circulars and outreach programmes are being done to inform them about annual identification/life certificate to be done on SPARSH. Aadhaar have also been taken from the banks in this regard. However, every pensioner (who has been migrated) is not expected to be informed/aware of entire process.


2. Therefore, it has been decided by the competent authority that, the banks may capture the life certificate of the pensioners identifying themselves with the banks, irrespective of their migration status. Identification/Life Certificate details/dates in respect of migrated pensioners may be provided to this office, so that the same may be incorporated in SPARSH. Above data is required to be shared in the following format in the 1<sup>st</sup> week of December 2022:

3. It is therefore requested to continue with identification facility to the migrated pensioners, who will visit bank branches in person. For pensioners who will submit their life certificate through Jeevan Pramaan, their data may be extracted and clubbed with the data of visiting pensioners in the same format.

4. In addition to the above, it has also been decided by the competent authority that willingness regarding provision of API integration to perform identification may be facilitated by the banks. If agreed, IT team of Bank and PCDA (P) may get in touch to work out the procedures. Confirmation for both (enabling identification and willingness for API integration) may be given through return mail before 20<sup>th</sup> October 2022.



3. Therefore it has been decided by the competent authority that, the DPDOs may capture their life certificate, in respect of SPARSH defence pensioners approaching their offices. In case, due to any reason, the life certificate is not being captured in system, the documents in support of submission of life certificate may be kept in record and the details may be consolidated in the following format and forward the same to Aashraya Team. Aashraya team will Consolidate the list received from DPDOs and will share the same with TCS for updation in SPARSH.


