The undersigned is to invite reference to Office Memorandum No. CGHS/NP/Admn./HEMP/2014/1758 dated 17.11.2014 vide which fresh empanelment of private Health Care Organizations (HCOs) and revision of package rates applicable under different categories for CGHS Nagpur have been notified.

1. The undersigned further invites attention to refer OM F. No. S.11045/36/2012/CGHS/HEC, GOI, CGHS, New Delhi, dated 10th Dec 2014 for Continuous Empanelment Scheme.
2. For empanelment of private hospitals, exclusive eye hospitals/centres, exclusive dental clinics, cancer hospitals/units, diagnostic laboratories & imaging centres under CGHS-2017, the application has been submitted for empanelment under CGHS by Shree Narayana Hospital (A Unit of Health-Tech Chhattisgarh Pvt. Ltd.), Near Ganj Mandi Road, Behind Sector 5 - Devendra Nagar, Pandri, Raipur-492001 (C.G.) with requisite documents including NABH recommendation certificate and have conveyed the acceptance of the CGHS rates notified under CGHS Nagpur and other conditions and also signed the Memorandum of Agreement with Additional Director, CGHS, Nagpur and furnished the appropriate Performance Bank Guarantee. Now this hospital is also included in the list of approved hospitals for empanelment under CGHS Nagpur.
