## NOTIFICATION

For empanelment of private hospitals, exclusive eye hospitals/centres, exclusive dental clinics, cancer hospitals/units, diagnostic laboratories & imaging centres under CGHS-2017, the application has been submitted for empanelment under CGHS by Vedanta Medical Research Foundation (Balco Medical Centre), Sector-36, Atal Nagar, Uparawara, Raipur-493661 (C.G.) with requisite documents including NABH recommendation certificate and have conveyed the acceptance of the CGHS rates notified under CGHS Nagpur and other conditions and also signed the Memorandum of Agreement with Additional Director, CGHS, Nagpur and furnished the appropriate Performance Bank Guarantee. Now this hospital is also included in the list of approved hospitals for empanelment under CGHS Nagpur.


3. The empanelment shall be for a period of two years from the date of issue of this notification or till next empanelment scheme comes in effect, whichever is earlier.
