Attention is invited to instructions contained in RBE No. 43/2015 which provide that while conducting selection against 33-1/3%, quota from erstwhile Group 'D' to 'C', panel should be drawn in the order of seniority from amongst the qualified staff as per provisions contained in para 189 of IREM Volume 1 and ACS No.154 & 155.


2. One of the Zonal Railways has raised a doubt as to whether the provision of supersession by 50% of the total field of eligible candidates by those securing 80 % marks and above, is applicable in case of promotion against the 33-1/3% quota of erstwhile Group 'D' (Level-1) to Group 'C' staff. The matter has been examined in the Board's office and it is clarified that the provision regarding supersession of 50% of the total field of eligibility by those securing 80% marks and above, and being classified as 'Outstanding', is not applicable in the selection procedure for 33-1/3% quota from erstwhile Group 'D' to 'C'. Past cases decided otherwise, need not be reopened.

3. This disposes off Northern Railway's letter No.831E/63-2/XIV-E/Pt-V/EIV dated 12.05.2023.
