

OFFICE MEMORANDUM

**Subject: Closure of Offices / buildings in connection with G-20 Summit, 2023 – regarding**

The G-20 Summit, 2023 will be held in Delhi during 9<sup>th</sup> and 10<sup>th</sup> of September, 2023. As a part of efforts to ensure foolproof security during G-20 Summit-2023, thorough Anti – Sabotage Checks are required to be done in the Buildings mentioned as Annexure well before the starting of G-20 Summit. These Buildings are required to be vacated from 0900 hrs on 08.09.2023 so as to seal the rooms after completion of regular anti-sabotage checks. The arrangements made by Delhi Police will be continued till 0800 hours on 11.09.2023. Besides, in order to sanitize the buildings, Roof-watchers are to be deployed. Due to which, it will be essential that buildings and the roof tops (as per list enclosed) are made available for thorough Anti-Sabotage Check.
