We kindly request you to raise these concerns with the Ministry of Finance, urging for the early declaration and issuance of DA/DR orders as well as the timely release of the Bonus orders. Such actions would not only alleviate the anxiety among the beneficiaries but also contribute to their financial well-being during these trying times.

Your support and timely action in addressing these issues will go a long way in ensuring the well-being and morale of the employees and pensioners associated with the Survey of India.
