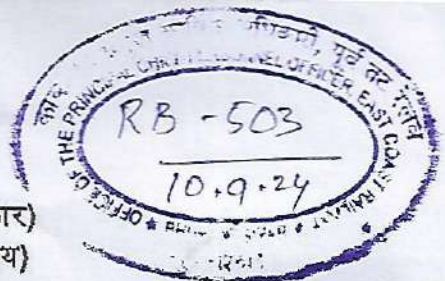

Accuracy of the monthly service review figures should be ensured and these figures must be uploaded on the HRMIS portal by 8<sup>th</sup> of every month in the prescribed format.
