PCDA (Pension), Prayagraj**FLAWS IN SPARSH PPOS NOTIFIED FOR OROP-III : SUB MAJ & HONORARY
LIEUTENANT AND SUB MAJ & HONORARY CAPTAIN**

1. It is intimated that this office is receiving lot of representations from the Pensioners (JCOs) regarding incorrect notification of SPARSH PPO for OROP-III revision for Sub Maj & Honorary Lieutenant and Sub Maj & Honorary Captain rank of the Indian Army. After scrutiny of their SPARSH PPOs notified for OROP III, it has been observed that as per their net Qualifying Service, rank and table of OROP -III, their Basic Pension have been notified incorrectly. Pension Disbursing Agencies (PDAs) are aware that as per this office Circular No. 555 dated 04.02.2016, pension of Armed Forces Personnel was to be revised w.e.f. 01.07.2014 as per tables attached with the Circular.


2. Now, Competent Authority has decided that terms of engagement mentioned in Appendix "X" of Circular No. 555 dated 04.02.2016 for under mentioned ranks may be revised w.e.f. 30.05.1998 as under:-

Navy	Master Chief Petty Officer-I and equivalent ranks	33 Years

	Hony Lt.	21 to 33 Years
Defence Security Corps (DSC)	Hony Lt.	21 to 33 Years
	Hony Capt.	21 to 33 Years
