**Sub: Grant of 18% House Rent Allowance to the staff working at Hasanparthi (HSP) and Pindial (PQL) Stations situated within 8 kms territorial jurisdiction of Warangal Municipal Corporation Area (Telangana)- Reg.**

**Ref: S.C.Railway's letter No. P[R] 54/HRA/HSP & PQL dt. 14.12.2022**

The subject proposal sent vide SCR's letter under reference has been examined in Board's office in consultation with Finance Dte./Railway Board and the same was sent to Ministry of Finance (Deptt. of Expenditure) for initial sanction which has since been received from Ministry of Finance (Deptt. of Expenditure). The President is, therefore, pleased to decide that Railway Staff working at Hasanparthi (HSP) and Pindial (PQL) Stations of South Central Railway may be paid House Rent Allowance at the rate applicable to 'Y' Class City (Warangal) rates, subject to fulfilment of conditions laid down for grant of House Rent Allowance.

2. The grant of HRA at higher rates shall take effect from the first of the month & year of issuance of the Dependency Certificates dt.16.11.2022 issued by Collector & District Magistrate, Hanumankonda, initially (a) for a period of three years or (b) till the places 'Hasanparthi (HSP) and Pindial (PQL)' continue to fulfil the conditions as laid down in para 2 of Board's letter dated 22.07.1965 as amended/modified from time to time or (c) till issuance of any further instructions in this regard by the Ministry of Railways, whichever is earlier.

3. The period mentioned at (a) of para 2 above, may, however, be extended after obtaining a fresh Dependency Certificate as prescribed in para 2 of Board's letter dt. 22.07.1965, as amended from time to time and in accordance with the provisions of Board's letter No. E(P&A)II-85/HRA-12 dated 11.03.1986.

4. This issues with the concurrence of the Finance Directorate of the Ministry of Railways.
