Further, pursuant to Clause 1 (ii) of Annexure - I of the norms prescribed for opening of new Kendriya Vidyalayas under Civil Sector, the sponsoring authority is required to transfer the identified and demarcated land free of cost to Kendriya Vidyalaya Sangathan on lease or permanent transfer basis prior to opening of the new Kendriya Vidyalayas. Besides, the rent free suitable temporary accommodation where the sanctioned KV will run initially (till the permanent building of KV is constructed) also needs to be handed over to the Kendriya Vidyalaya authority. Moreover, KVS is not mandated to pay any kind of fees etc. for such transfer of land for educational purposes and being a Central Government property, KV school building will be exempted from the charges such as property tax/Service tax/Municipality taxes etc.
