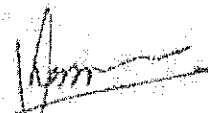
Sub: Provision of bedrolls kits to RAC Passengers in AC Classes.

At present RAC passengers are charged fares at par with passengers holding confirmed reservation, but not provided with bedroll facility, in AC Classes (except AC Chair Car) since one berth is shared by two RAC passengers.

2. Board has examined the matter and it has been decided that Blanket and a Bedsheet may be given to RAC passengers travelling in AC Classes (except AC Chair Car) as the bedroll charges are included in fare being collected from them and it is also a requirement in AC Class.

3. This has approval of the Board (MT).

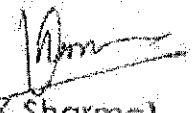

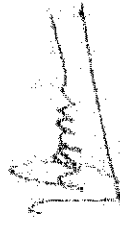

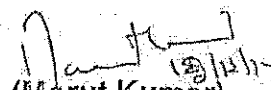
Sub.: Provision of two bed roll kits to RAC passengers in AC classes (Except AC Chair Car).
