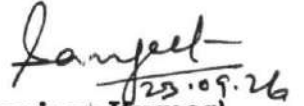

01.07.2026 - reg.**

The flat rates of Licence Fee (Standard Rent) for residential accommodation all over Indian Railways were last revised w.e.f. 01.07.2023 vide Board's letter of even number dated 27.10.2023. Ministry of Railways has now decided to revise the Licence Fee (Standard Rent) for residential accommodation all over the Indian Railways w.e.f. 01.07.2026, as shown in the Annexure-A.

2. The revised rates will be effective from 01.07.2026.
3. The revision shall be valid for residential accommodations all over the Indian Railways. However, it does not apply to sub-standard accommodation.

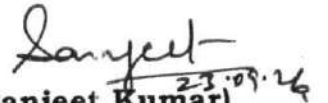
